5. Fee for prolonging the Master's Thesis (MFW): (can only be used once)

The amount of the fee for prolonging the Master's Thesis, (only for students who were enrolled for the immediately previous Academic Year) is set at 500, 00€.

Payment deadline for the MFW: 30th December, 2020

6. Application Fee:

The amount of the application fee is set at 50, 00€.

7. Re-enrolment:

The amount of the re-enrolment fee is set at 60, 00€.

Re-enrol and Payment deadline of fee: 30th July, 2020

Payment deadline of the 1st semester CU: 30th September, 2020

Payment deadline of the 2nd semester CU: 30th March, 2021

MFW – The tuition fee to be paid is divided into 2 equal instalments, in accordance with the payment deadlines set in 1.2 and 1.3 for the 1st and 3rd instalment.
