APPENDIX

Admission and Ranking of the Student Applicants for the Masters in Finance

Prerequisites

To be able to enrol at ISEG's Masters in Finance, applicants must hold a Bachelors degree (licenciatura) by the end of the previous academic year. International applicants should hold an overseas qualification of a similar standard, from a recognised higher education institution. Failure to prove existence of such degrees before the deadlines, corresponds to cancellation of the associate application, with no guarantee of future acceptance.

Calculation for the Grading of the Candidates

1. The ranking is based on a Score awarded to each candidate and calculated according to the process described below. This only applies to students who have satisfied the prerequisites. Whenever necessary the Masters Coordinating Committee may decide to interview candidates. Most students are excused from the interview and their score is the weighted average of points according the Table A).
