**6. Fee for repetition/prolonging the Master's Thesis (MFW) 90 ECTS:**

**6.1. Prolonging the Master's Thesis (MFW):** (can only be used once and in accordance with one of the options in sub-paragraphs a and b)

- a) The amount of the fee for prolonging the Master's Thesis (only for students who were enrolled for the immediately previous Academic Year) is set at 500, 00€.

Payment deadline for the MFW: 7 days after the request for the prolonging/extension of the MFW, on the academic portal.

- b) The amount of the fee for prolonging the Master's Thesis (only for students who were enrolled for the immediately previous Academic Year) is set at 500, 00€. (adds repetition charge)

Payment deadline for the MFW: 30<sup>th</sup> December, 2022

**6.2. Repetition Master's Final Work (MFW):** (third or more consecutive entries)
