

The ISEG Confidence Index is new in the press

The ISEG confidence index for November 2020 for the short-term evolution of the Portuguese economy assumed a value of 27.4, which represents a stabilisation of confidence compared to the previous month's value. In year-on-year terms, the variance in the value of the index was -21.3%. The level of consensus regarding the economic outlook amongst the members of the Panel decreased.

Research at ISEG is unstoppable



- 2. Fresh basil- 3 leaves 3. Red fruits jam - 1 soup spoon


