### Study Program:

The School offers the following master's programs for student exchange:

- Master of Accountancy 1)
- Master of Science in Business Analytics 2)
- 3) Master of Science in Finance
- 4) Master of Science in Information (Science) and Technology Management
- 5) Master of Science in Management
- Master of Science in Marketing
- Master of Science in Real Estate

Exchange students need to indicate their preferred study program at the time of application and take majority of courses offered by that master's program during exchange. Taking courses offered by any other master's programs in the Business School will require approval of the program directors concerned.

# **Teaching** Arrangement:

The default mode of delivery of teaching and learning will be in person and on campus for all classes. Students should strictly observe the University's guidelines on COVID-19 prevention measures when attending face-to-face meetings, classes or examinations.

Medium of Instruction: All master's courses are taught in English with the exception of some courses of a unique nature in which teaching in Chinese is preferable. While exchange students are not required to provide specific GMAT (verbal), IELTS or TOEFL scores, exchange students must be proficient in English.

### Course Load:

Exchange students are eligible to take taught postgraduate courses at 5000 or 6000 level in programs or departments in CUHK Business School under a specific list of courses, except certain courses with specific prerequisites. All coursework should be approved by the home university to ensure compliance with the requirements of your degree program.

At CUHK, one unit is roughly equivalent to one hour of instruction per week. A 3unit course meets for 39 to 42 contact hours (or 1.5-unit course for 21 hours) in total. Exchange students will need to take a full load of courses, meaning between 9 units (117 to 126 contact hours) and 18 units (234 to 252 contact hours) per term. Students should consult their home institution for advice on taking appropriate units of courses for later credit transfer.

**Course Selection:** 

Course information is available online: https://masters.bschool.cuhk.edu.hk

The list of courses offered in 2023-24 will be released to exchange partners between June to July. Some classes are scheduled in the evening on weekdays or at weekends. While most classes are conducted on CUHK campus, some may be conducted off-campus. Exchange students should take the above under consideration when making their course selection.

Learning Expectations:

Master's programs place primary responsibility upon individual faculty members to decide on the course materials and method of teaching which will prove most effective in realizing the objectives of the course and are most suitable to the subject matter. No matter which course materials or delivery methods are adopted, they must pertain to achieving a balance between theory and practice, with a clear emphasis on relevance.

Teaching methods commonly used include lectures, discussions, case analyses, seminars, gaming models and directed research. In addition, company tours, surveys and field work are done by students, and local business practitioners are invited to give guest lectures or lead in-class discussions.

Attendance is mandatory and active class participation is expected. Normally the class size ranges from 20 to 80 depending on the nature of the courses.

Assessment:

The format of assessment varies from course to course. If there is a final examination, it will be held during the last week of the term or during the examination week, unless specified.

**Language Courses:** 

Intensive Chinese language courses are available at CUHK. Students who wish to take Chinese language courses at CUHK are required to pay additional tuition fees. Additional information can be found <a href="https://example.com/here">here</a>.

**Grading Scheme:** 

Student performance is assessed on a course-by-course basis. Grades for graduate-level courses are recorded by letter, but grade points are used to compute grade point averages. The letter grades and the corresponding grade are as follows:

"DI"/"PA"/"FA" or "P"/"U" grades are for specified courses adopting distinction/pass/failure and pass/failure gradings where other grades are not applicable.

**Transcripts:** Any academic credit received during the course of studies will be transferred to the

home university according to the appropriate regulations. Exchange students can

apply for the transcript or certifying letter through the OAL.

## **Accommodation and Expenses**

Accommodation: On campus housing is not available for exchange students. Exchange students

must make their own housing arrangements. The Office of Student Affairs provides students with information related to rental accommodation outside CUHK campus: https://lces.osa.cuhk.edu.hk/non-local-services/housing/off-campus/introduction/.

Academic Expenses: Books and class reading materials around HK\$5,000 per term

**Living Costs:** An estimated cost of living, not including housing, for an exchange student in Hong

Kong is around HK\$33,100 for one term but the expenses vary greatly depending

on the lifestyle.

**Pre-arrival**All exchange students are affiliated to International Asian Studies Programme Information:
(IASP). For pre-arrival information such as visa application and student

Visa: All exchange students MUST apply for a Hong Kong student visa (not a China visa)

before arriving in Hong Kong. Applications should be sent directly to the Hong Kong Immigration Department via the OAL. OAL will send you the application information

and timeline in due course.

Health Insurance: Incoming exchange students holding a valid student visa with a stamp from the

Immigration officer when you enter Hong Kong are entitled to fees and charges for "Eligible Persons" in Hospital Authority institutions within their duration of stay in Hong Kong. This means they can enjoy discounted rates for public health services and are exempted from surgical and hospital insurance. Please visit

Apart from that, exchange students should also arrange at their own cost in the accident and sickness insurance coverage with provisions for emergency evacuation/rescuer's expenses and repatriation for the duration of their studies in Hong Kong. If they have plans to travel outside Hong Kong, they should make sure that their insurance policy covers those regions as well included in their parents' health insurance policies, they should check the coverage before coming to Hong

Kong.

Exchange students are reminded to bring a copy of their insurance policy to Hong Kong. When they report arrival at CUHK, they will be asked to submit a copy for

emergency use.

Services and Facilities:

A range of academic facilities and resources as well as useful support services enhance students' learning and living throughout their study period at CUHK:

**Computing facilities** are available at several 24-hour labs run by the Information Technology Services Centre. The **University Library system** is one of Hong Kong's most comprehensive collections. The **University Health Service** provides





primary medical care. Appointments can be made in advance by phone or through an internet booking system. **Sports facilities** include a sports field for track and field, gymnasiums, an Olympic-sized swimming pool, tennis and squash courts, weight training rooms and a water sports center.

**Career Services:** 

Our Business School Career Management Centre (CMC) offers a wide range of activities to enhance students' professional knowledge and personal skills, including individual coaching, career trainings/workshops, recruitment talks, leadership sharing and company visits.

# **COVID-19 Related Arrangement**

The policies and requirements for inbound travelers have been updated by the Hong Kong Special Administrative Region (HKSAR) Government.
