4. Payment for Repetition of Curricular Units (CU):

Payment deadline of the 1st semester CU: 30th September, 2017

Payment deadline of the 2nd semester CU: 31st March, 2018

5. Fee for prolonging the Master's Thesis (MFW):

The amount of the fee for prolonging the Master's Thesis, (only for students who were enrolled for the immediately previous Academic Year) is set at 500, 00€.

Payment deadline for the MFW: 5th January, 2018

6. Application Fee:

The amount of the application fee is set at 50, 00€.

7. Re-enrolment:

The amount of the re-enrolment fee is set at 60, 00€.

Payment deadline of the 1st semester CU: 30th September, 2017

Payment deadline of the 2nd semester CU: 31st March, 2018

MFW – The tuition fee to be paid is divided into 2 equal instalments, in accordance with the payment deadlines set in 1.2 and 1.3.

8. Separate Curricular Units:
