## ACADEMIC CALENDAR:

The academic year is divided into 5 blocks of 6-8 weeks. Exchange students can participate per block or combine consecutive blocks.

### Fall term: September – December:

- Block 1 (early Sept - end Oct)
- Block 2 (end Oct – mid-Dec)

### Spring term: Early February – June:

- Block 3 (early Feb-mid-March)
- Block 4 (end March-early May)
- Block 5 (mid-May – end June)

In general, exams are scheduled at the end or, the week after each block of classes. Re-sits, however, take place in early January (block 1), mid-March (block 2), early May (block 3), end of June (block 4), end of July (block 5)

## LEARNING EXPECTATIONS:

Teaching Language	English
Duration	<p>Students can participate in either 1 or both blocks in the fall term and 1, 2 or 3 blocks in the spring term. A full year exchange includes blocks 1 – 4 or 5.</p> <p>Students are expected to complete their entire exchange programme at RSM including final exams. Neither exemptions nor special arrangements with teaching staff can be made to schedule exams or re-sits on other dates, times, or places.</p>
Introduction	<p>At the start of each full-term programme, introduction activities are being organized. Exchange students are strongly recommended to participate in order not to miss out important programme information and it is THE day to meet all fellow students.</p>
Workload	<p>Courses are valued with European Credits (EC, formerly ECTS). At RSM, 1 EC represents 28 student working hours which include in-class hours, self-study, group work, reading/writing papers, exam preparation.</p> <p><u>Fall term:</u> The minimum workload for the full term is 20 EC (Block I &amp; II). Because of the demanding and intensive character of master core courses, the recommended maximum workload is 24 EC.</p> <p><u>Spring term:</u> The minimum workload in electives for the full term is 18 EC (Block 3 &amp; 4 or 20 EC (Block 3, 4 &amp; 5). The maximum workload is 18 EC for one block. The recommended maximum workload for the full term including all three blocks is 24 EC.</p> <p><u>Full year:</u> Students staying for the full year (Block 1 till 4 or 5) need to obtain a minimum of 40 EC.</p> <p><u>Short term:</u> Students staying for one block only, need to obtain the minimum workload of 12 EC.</p>
Examinations	<p>Assessments are based on written or take-home exams, progress reports, in-class presentations, group performance and essays.</p> <p>Within some Master programmes there are some courses that are evidence-based knowledge courses where students obtain a pass or fail, instead of a numeric grade. This is mentioned in course information that is shared with the students.</p>

Grading	The Dutch grading system uses grades 1 to 10, with 1 being the lowest and 10 the highest. Grades are generally rounded to 1 decimal place. Grades with a 0.4 or lower will be rounded down, and grades with a 0.5 or more will be rounded up. Transcripts from students in our exchange programmes will show grades to 1 decimal place. Class profile	The master programmes are pre-experience programmes, average age of students is 22-25 years. Most students have some relevant working through internships, part-time management jobs, business projects or start-ups.

## CURRICULUM:

Courses at RSM	<p>Courses of the following specialized <a href="#">Master Programmes</a> are open to exchange students: Accounting and Financial Management, Business Information Management, Finance &amp; Investments, Global Business &amp; Sustainability, People, Organisations &amp; Change, Management of Innovation, Marketing Management, Supply Chain Management, Strategic Entrepreneurship and Strategic Management. Students can participate in a combination of courses from different master programmes if timetables do not collapse. An exception is the People, Organisations &amp; Change master programme. If students want to participate in courses from this master programme in the fall term, they are required to take all the courses in both blocks. In the Finance &amp; Investments master programme, there are some courses that need to be taken in both blocks in the fall term as well. Students are informed about this in course information that is shared with them.</p> <p>For course information, please see: <a href="#">Course Catalogue</a>.</p> <p><i>Note: MBA students from our MSc partner schools cannot enroll in MBA courses. The MBA exchange programme maintains its own network of partner schools.</i></p>
Course registration	There are several registration rounds to register for courses. Students will be instructed about 1 week prior to such an registration round.
International Consultancy Project	<p>The cornerstone of the Master Exchange Programme is the International Consultancy Project (<a href="#">ICP</a>). The ICP has a workload of 12.5 EC.</p> <p>In a team of 4/5 international students, all with different backgrounds, competences and skills, students work intensively on a consultancy project for 4 months. Both coaches from the university and company supervise the project and the aim is to respond professionally to a real-world management problem and to learn from working in multidisciplinary and culturally diverse groups.</p> <p><b>Open to</b> full term exchange students only. Because of its' professional and intensive character, students are strongly advised not to take more than one course per block parallel to the ICP.</p>

## ADMISSION REQUIREMENTS

<b>Open to</b>	Students who are studying at our MSc/MBA partner schools and who are selected by their home university. Open to Master and MBA level students.
<b>English requirement Exchange programme</b>	<ul style="list-style-type: none"> <li>TOEFL (iBT) score of 80+/4.5; minimum sub score of 18/4.0 for reading &amp; listening, 20/4.0 for speaking and 21/4.5 for writing.</li> <li>IELTS 6.5; minimum sub score of 6.0 for reading, listening, speaking, and writing.</li> <li>CEFR level B2</li> <li>Cambridge FCE/CAE/CPE/BEC Higher 170; minimum sub score of 170 for reading, listening, speaking &amp; writing.</li> <li>Pearson PTE score of 70+; minimum sub score of 65+ for reading, listening, speaking, and writing</li> <li>LanguageCert Academic score of 70+; minimum sub score of 65+ for reading, listening, speaking, and writing</li> <li>Another English language certificate of a comparable level with comparable (sub)scores.</li> </ul> <p>NOTE: we do not accept language statements from universities, unless it is a statement that the entire programme is taught in English</p>
<b>English requirement International Consultancy Project</b>	<p>For participation in the International Consultancy Project (ICP) within the Master exchange programme, higher English language requirements apply:</p> <ul style="list-style-type: none"> <li>TOEFL iBT score of 95+/4.5, with a minimum of 23/4.5 on reading, speaking, listening and writing.</li> <li>IELTS score of 6.5, with a minimum of 6.5 on all sub scores.</li> <li>We do not accept language statements from the partner university for participation in the ICP, unless it is a statement that the entire programme is taught in English</li> </ul>
<b>English exemption</b>	Non-native speakers whose current study programme is entirely taught in English and native speakers are exempted from the above-mentioned requirements, though this needs to be shown in your current transcript or any other official document.
<b>After nomination at RSM</b>	About a month prior to the student's application deadline, nominated students will receive a Welcome Email with instructions for the online application system, information about visa and residence permit (if applicable), accommodation, academic calendar, and other relevant information to help them prepare.
<b>Deadline application</b>	<p>It is the student's own responsibility to submit the exchange application in time.</p> <p>Fall: May 15</p> <p>Spring: October 15</p> <p>Late applications will not be dealt with unless agreed upon with the partner school.</p>
<b>Required documents</b>	<ul style="list-style-type: none"> <li>Completed RSM online application</li> <li>1 digital passport size photo (jpg file)</li> <li>Scan of a recent official transcript (or academic report) showing grades, from the first year to the latest results</li> <li>Proof of proficiency in English</li> </ul>
<b>Information during and after the application process</b>	Students can check their status in the online application system. Upon approval of the application, students will receive at least consecutive 2 email messages:

	<p>1) One with information on the course registration including specific information about the courses, timetables, etc.</p> <p>2) The other with more detailed information on the introduction, arrival in the Netherlands, the Exchange Ambassador Programme, which is also referred to as the 'final Information email'.</p> <p>The Letter of Acceptance is sent to students through the online application system.</p>
Visa/residence permit	Students with a non-EU/EEA nationality might need to obtain an entry visa and/or a residence permit to study in The Netherlands. If applicable, students can indicate this in our application system which will initiate the immigration procedure. Visa requirements are subject to change. Always check: <a href="#">Immigration   Erasmus University Rotterdam</a> .
Costs of living	The estimated costs for living and studying in Rotterdam is <u>approximately €1000-1800 a month</u> . These costs include visa and/or residence permit (if applicable), living expenses, health/3d party insurance (mandatory), books, meals & drinks. However, all costs depend on a student's personal spending pattern and therefore costs may vary.
