Tribute to Pereira de Moura: 23 April 2025, 18.00, ISEG Library

Francisco Pereira de Moura was born on 17 April 1925. To commemorate the centenary of his birth, ISEG is organising several initiatives. Next Wednesday, 23 April, a **Memorial Tribute** will take place in the **ISEG** Library atrium at 18.00, followed by the opening of an exhibition dedicated to his life and work. The memorial tribute will count with the presentation of **ISEG's Historical Archive**, whose first collection research work ever to be made available online, is that of Pereira de Moura.

Francisco Pereira de Moura was one of the most notable Portuguese of the 20th century. He stood out for his academic work and his political and social intervention. Much of his professional life was spent at ISEG, where he was responsible for educating generations of economists. Since the 1950s, he played a central role in modernising the teaching of economics in Portugal, introducing subjects and methodologies at the vanguard of international best practice.

His political intervention was more significant from the end of the 1950s onwards, continuing throughout the 1960s and 1970s. When the 25 de Abril revolution took place, he was undoubtedly one of the country's most well-known and recognised personalities. Whereas on the military side, the three most prominent figures are, for different reasons, **António de Spínola**, **Otelo Saraiva** de **Carvalho** and **Salgueiro Maia**, on the civilian side, the three most prominent figures of those days are **Mário Soares**, **Álvaro Cunhal** and **Pereira de Moura**.

After the years of the Revolution and because the country had entered a period of stabilisation, Professor Pereira de Moura then devoted himself entirely to ISEG. He was the Dean of the School in 1979-80 and then chaired its Scientific Board in 1984-86 and 1989-90. To a large extent, the foundations of today's ISEG were built by him, together with other colleagues with whom he worked, ensuring the continuing development of a professional faculty. Just as an example: in 1983 there were only 9 professors with a PhD at the school, yet today the number is close to 200. It was at this time that he was involved in launching Master's degrees at the School. As well being involved in the School's organisation, he continued to devote himself to teaching until he retired in 1995, coordinating teaching teams for subjects related to Economics. In this context, he contributed to the tutoring of younger members of faculty and was responsible for the adoption of working methods that determined the quality of the teaching we offer today.

Pereira de Moura made a decisive contribution to making ISEG a school where theoretical, doctrinal and political pluralism prevails, as well as a humanist dimension in teaching and collective coexistence. Recognising the decisive nature of his many contributions, ISEG paid tribute to him in due course. Today, the Francisco Pereira de Moura Library is located in the centre of ISEG's campus, precisely where the Memorial Tribute will be held on 23 April and where an exhibition on his life will be inaugurated, which will be open to the public over the coming months.





As part of the celebrations to commemorate the centenary of the centenary of the **birth of Francisco Pereira de Moura**, ISEG is going to hold a **memorial tribute**, **followed by the official opening of an exhibition and historical archive** dedicated to the life and legacy of Francisco Pereira de Moura, one of the most remarkable Portuguese men of the 20th century.

Economist, academic, politician and a citizen who was committed to building a fairer country, Francisco Pereira de Moura left a deep mark on contemporary Portuguese history - and on ISEG, where he was a student, professor and the Dean. This will be a moment of reflection and tribute, where we will celebrate the exceptional career of a unique figure in our history.

IRS and Freedom: The State is not a bank vault | The money is yours, not the State's



The controversy surrounding lower-than-usual refunds and extra payments of IRS in 2025 reveals something deeper than just a simple tax issue: it's a **debate about the role of the State, individual responsibility, and the financial maturity of society**. The Government's decision to reduce withheld tax rates for 2024 was the right one and technically well-founded. Instead of withholding too much and then paying it back – being in effect forced savings without earning interest – the State no longer acts as an

and then giving it back as if it were giving a present. With this change, taxpayers now have more liquidity throughout the year, which means greater freedom and autonomy in managing their income. This measure is sound, because it brings the withheld tax closer to the actual tax, reduces administrative costs and unnecessary refunds, and – most importantly – it promotes financial literacy by giving citizens direct control over their income.

Even so, many interpreted the change as a problem. Now, faced with having to pay, they feel surprised. But this isn't a system error: it's the system working as it should do. The resistance isn't the result of a technical fault, but rather from the absence of healthy financial habits. The alternative – withholding more and giving it back later – is simply a way for the State to manage people's money as if it were its own, as if we are all children who need an allowance managed by a State 'father'. And worse: with an allowance that is given to us later on, as if it's a generous gift.

This view is not only arrogant, but it's also dangerous and infantilises society. It assumes that citizens are not capable of managing what is theirs, and that the State must intervene to 'protect' them from themselves. **But this isn't protection - it's control, exacerbated control**. And control breeds dependency.

The debate is therefore not just technical – it's ideological. On the eft, the vision of a having 'guardian State' persists, a State which collects and redistributes based on a deep distrust of the autonomy of its citizens. The Right, on the other hand, defends individual responsibility, freedom of choice and the idea that taxpayers are the best managers of what is theirs.

The future is built with informed citizens who are capable of making their own decisions – not one with a resigned population, which is kept in a state of financial ignorance that suits those in power. We need an adult society, that is aware of its duties and rights, and which is not dependent on favours from the State. The question is simple: do we want a country of free adults or one of tutored minors? I

choose freedom – with responsibility, autonomy and confidence in the maturity of citizens. In this issue, we highlight:

ISEG professors among the 50 Most Influential Women in Portugal



Professors Clara Raposo, Sandra Maximiano and Sara Falcão Casaca were distinguished for their impact and leadership in the areas of economics, regulation and gender equality, respectively.
Clara Raposo has been a Deputy Governor of the Bank of Portugal since 2022 and is the second woman to hold this position. Before that, she was the Dean of ISEG, where she promoted a culture of innovation and internationalisation.
Sandra Maximiano, a professor of economics at ISEG, was appointed Chair of ANACOM in 2023, taking on a leading role in the regulation of communications in Portugal.
Sara Falcão Casaca, a researcher and professor at ISEG, is a national reference in gender studies and equality policies, with an academic and civic career dedicated to promoting equity at work and in society as a whole.
The Executive list also includes two ISEG alumni: Ana Figueiredo, Chair and CEO of Altice Portugal/MEO, with a degree in Management, and Ana Garcia Martins, author of 'A Pipoca Mais Doce', who holds a postgraduation in Marketing Management.

ISEG Research rated 'Excellent' by FCT with funding of 6.5 million euros



ISEG's research unit – **ISEG Research in Economics and Management** – has been rated '**Excellent**' by the **Foundation for Science and Technology (FCT)**. **ISEG Research** is the largest research unit in Portugal in the areas of Economics and Management, with 195 researchers and funding that totalled 6.5 million euros for the period **2025-2029**.

The evaluation panel awarded the maximum score for both the team and the strategic project proposed for 2025-2029. This result reinforces ISEG's position as a leading school in the production of knowledge in economics and management in Portugal and Europe.

CEsA participates in European consortium for #DemocracyinAction project



CEsA – Centro de Estudos sobre África e Desenvolvimento/ISEG Research has joined a European consortium, coordinated by the University of Leiden, to carry out the **#DemocracyinAction: Grassroots Culture, Arts and Cultural Spaces for Political Participation and Expression Online and Offline in a Resilient Europe** research project, funded with three million euros by **Horizon Europe**.

Professors Jessica Falconi and Iolanda Évora are coordinating Work Package N° 5: Race, Ethnicity and Civic Participation, which focuses on the cultural and artistic production and spaces created by communities from the African diaspora, as well as the artistic production of the Roma community in Portugal and the Moroccan community in Spain. This research will be carried out in collaboration with local Portuguese and Spanish organisations.

The first meeting of the project took place at ISEG from 12 to 14 February and brought together more than 20 European researchers and activists.


ISEG Alumni Económicas celebrates its 34th anniversary with a conference and commemorative dinner
